You are invited to participate in a stimulating short course on Gender, Violence and Health

In recent decades there has been a greater recognition of the extent and consequences of gender-based violence worldwide. Gender-based violence is a major contributor to the burden of disease and is also huge economic cost. An awareness of the prevalence of gender-based violence and an understanding of its impact on individuals and society are important pre-requisites to informed practice in many fields including health promotion, public health policy and practice, social policy and advocacy.

During an intensive four-day course, you will have the opportunity explore the intersection of gender and violence as well as the importance of other social and contextual factors. The course will also cover the impact of various forms of violence on physical and mental health and wellbeing. In addition, it will examine the barriers to researching, understanding and responding to gender-based violence.

Philomena Horsley will coordinate the course. Philomena is a medical anthropologist who has extensive experience of working in the field of women's health. Experts from a variety of fields will contribute their knowledge.

This course is open to all. You do not require academic qualifications to enrol, and you will not be required to undertake formal academic assessment. If you would like to understand more about this significant social and health issue, this course is for you.

Short course in GENDER, VIOLENCE & HEALTH

Violence is a major concern worldwide, with negative effects on women, men and children. In Victoria, it is the major cause of disability, illness and death amongst women of reproductive age. In this subject we cover the definitions, conceptualisation and prevalence of violence and will use a gender lens to consider a broad range of topics including childhood sexual abuse, intimate partner violence and sexual assault.
